

Educational Forums

Dear HFMA Southwestern Ohio Chapter Members:

The Educational Forums will begin this year with a special summer session on August 14th at West Chester Medical Center. Be sure to mark this date on your calendar. The 8:00-12:00 session will be “Best Practice RAC Response” presented by the Advisory Board Company. The announcement will include more details.

We are arranging a great slate of programs for the 2009-2010 educational year. Topics for this year’s calendar include Revenue Cycle, Reimbursement, Managed Care, Compliance, Physician, Accounting and Decision Support. The Season Pass options offer a great value on programming that is relevant to Healthcare Finance. Times and Locations:

Generally, Forum sessions will be held on the 3rd Friday of the month in Room G on the lower level of the Conference Center at **The Drake Center** (see map at the web site). The exceptions are the December Forum scheduled on December 11th, the November 20, 2009 Forum at the Atrium, and the March 19, 2010 Forum at West Chester Medical Center. The Drake Conference Center is easily accessed by entering the West Pavilion entrance and taking the elevator on your right to Level A and following the signs. On each of these dates, with the exception of August 14, 2009 Forum, the chapter will offer two Forum sessions, the first from 8:20 a.m. to 10:00 a.m. and the second from 10:20 a.m. to 12:00 noon.

Registration Fees:

Walk-in registration will occur prior to the Forum session beginning at 8:00 a.m. The fees will be **\$25** per Forum session for HFMA members and **\$40** for non-members.

As an alternative, HFMA members can purchase a **“Season Pass” for only \$125**. The Season Pass will give members access to many hours of programming, at any of the Forums for just one low price. (Compare this to the price of CPE elsewhere, what a great value!) The Season Pass will provide you unlimited access to any Forum session and will expire at the end of the Forum season in 2010. [Registration for the TriChapter event at Belterra in September, and the 2010 May Institute will **not** be included in the Season Pass.] A Season Pass registration form is enclosed. To receive a Season Pass, complete the form, enclose a check made out to Southwestern Ohio Chapter - HFMA for the appropriate fees or provide credit card information and return to Diana Feldman-Smith as soon as possible, especially if you are planning to attend the August 14 Forum.

There are two options for organizational season passes this year. There is the **Organization Season Pass** which allows a company to send up to **three individuals** to each Forum session under the season pass (this includes non-HFMA members. The Organization Season Pass is available for only **\$325**. There is also the **Corporate Season Pass** which allows a company to send up to **six individuals** to each Forum session (again including non-HFMA members) The Corporate Season Pass is only **\$625**.
